In consideration of being allowed to participate in the services and activities, including, moto-x riding, cafe access and any other amusement activities provided by Hypertracks UK Limited and its agents, owners, officers, directors, principals, volunteers, participants, clients, customers, invitees, employees, independent contractors, insurers, facility operators, land and/or premises owners, and any and all other persons and entities acting in any capacity on its behalf (collectively "Hypertracks"), I agree as follows:

1. I am 16+ years old and wish to participate in the

9. I certify that I and any children in my care are in good health and in proper physical condition to participate in the ACTIVITIES;

11. I accept sole responsibility for my own conduct and actions, as well as the conduct and actions of the children in my care participating in the ACTIVITIES.
